

Corona News 08/03/2021 The chaos is entering a new round

I can hardly believe it: It was decided last week and introduced from Sunday that returnees are subject to corona checks. First of all, fact. But I can't believe it: What are the politicians in charge actually doing besides making vague, incomplete, sensible regulations, as is always the case in this pandemic? Do not even manage to make a sensible, forward-looking and well thought-out rule that everyone understands, that includes all cases and that works. No, they are obviously not able to do that. But cashing in on fat diets is always possible.

What do i want to say The controls were ONLY defined for travelers by plane. And there are also ambiguities, as Mr. Müller, the governing mayor of Berlin, admitted on July 29, 2021 in the talk show with Markus Lanz without further ado. But from the beginning. As I said, let's look at the planes. Anyone who comes back, as an unvaccinated person, has to be in quarantine for a certain period of time, whether 5 days, 10 or 14 days, who knows. But obviously only applies to adults. Because Müller claims: Nobody can do that with children, because there are still no vaccinations for children. In addition, the children will be tested 3 times a week from August 9th, when school starts in Berlin. And totally vaccinated people don't need to be quarantined anyway. Too bad, some have already planned and booked their vacation before the regulations and may not come back from vacation until August 8th and have to work again from August 9th. The employer is happy. And what about a child if the parents have to be quarantined?

It becomes even more opaque with train passengers. According to a statement by a lawyer on SAT 1 breakfast television, a sample rate of 20% is aimed for. As it is with motorists, there are actually no national borders in the EU, who knows. A journalist from Berlin, who claims to live in a district with a high incidence, also proves how chaotic and opaque the whole thing is. You don't know who has to watch or do what and when. Likewise, she wonders what about students. She does not know the current requirements. It doesn't help if the science editor of the Süddeutsche Zeitung Christina Berndt jumps into the breach for Müller by claiming that the rules would and must be continuously adapted and that nobody would know beforehand what to expect. Total nonsense, Mrs. Berndt. She also has no perspective, which she proves with this statement. Basically it's really quite simple with the rules, I don't understand why that is not buckled: Politicians could easily have determined exactly BEFORE the start of the trip in June 2021: What applies to high-risk areas, high-risk areas, variant areas for children and adults. From what incidence do which measures have to be taken as a traveler? Where is the problem. Am I just smarter than them or is it just the wrong people who discuss and decide something like that? I firmly believe the latter is the case. And one more sentence about Müller's statement that they want to prevent those returning from traveling with them from increasing incidences. He should actually laugh himself at this stupid statement. We've known for weeks that the incidence is rising again, precisely because of returning travelers. And if the controls are only random, you can leave them alone. What's that about ? Do you play the lottery in the federal government, with luck a few hits, and the others get through? I can only hold my head on the basis of such decisions.

The regulation of individual countries to simply offer children and young people a vaccination offer fits in with the whole chaos, even if the STIKO has not yet made a general recommendation. Politicians have no idea how it works in children and adolescents, but if you need higher vaccination numbers to allegedly achieve the herd immunity that you will never achieve, you believe the words of Prof. Streeck, and you believe the adults who have not yet been vaccinated try to do it with gullible children and adolescents. Allegedly only possible after a detailed discussion and the consent of a doctor. Well, and the parents as legal guardians are not asked?

Also because of the ever decreasing daily vaccination rates, new possibilities are being sought to somehow keep the rate high or to push it. Because especially with the over 60-year-olds, where everything was sucked so nicely at the beginning of the vaccination campaign, everything came to a standstill, not even 80% in this age group received complete vaccination protection, in Saxony as the worst country only just over 70% . Where it is precisely this group that is said to be particularly at risk. It was always said. But in the meantime the group of students and co. Has been identified as the target group. Important to know: The group that is hoped to have increased vaccination numbers is always declared as a vulnerable group. So everyone gets a turn.

And that is precisely why new theoretical medical wisdom is now being spread. So that citizens, including you, are convinced of the advantages of mRNA vaccines, they should now also be used against diseases such as malaria, flu or cancer. Cancer, a disease that Walter Scheel's wife, Mildred Scheel, took on during her lifetime. In 1974 she founded the German Cancer Aid with 7 members. After that, various other organizations were founded. But to this day, despite billions in cancer, no groundbreaking measures have been devised or found, because even today body-damaging chemotherapy, a cocktail of various drugs, is still used. And now suddenly, after 47 years, someone thinks they have the solution to the riddle. Where the mRNA vaccines and modes of action have not even been fully researched, nothing is known about long-term effects, but you can already pump the substance further into people's bodies. The next side effects are already inevitable. Somewhat stupid then is the sentence that vaccines against previously deadly virus infections beckon. Didn't even know that malaria or cancer is a viral disease. But what I do know and have been confirmed and proven by studies: That the mRNA vaccine intervenes deeply in the body's immune defenses and makes changes here. It remains to be seen what and whether these will be so positive in the future or lead to the dire effects of other diseases, as described in a study. We now have enough test subjects.

And speaking of life-saving ways of dealing with corona: AOK figures now show that there is a high mortality rate in Germany for people who have to be connected to so-called ECMO ventilation due to severe corona disease. ECMO, extracorporeal membrane oxygenation and extracorporeal lung support are used in intensive care in hospitals for patients who cannot or can only breathe with difficulty on their own. The machine then partially or completely takes over the patient's respiratory functions. So far it all sounds great. This system should of course save lives and bring the patient through the days when one would probably die without it. Official figures indicate a death rate reduction of well over 50%. Now it gets strange or even dramatic: Of 100% ventilated ECMO patients during the Corona times, between 56 and 88% died, depending on the age group, while the rate in other countries is just half as high. This is the conclusion reached in this study by doctors and experts from various clinics and universities in Cologne, Regensburg, Würzburg and Berlin.

The study involves 768 participants of various age groups. The reasons why the death rate is so high in Germany cannot be determined with certainty in the study. The assumption is that the treatment was sometimes started too late, that the number of operators is too small and, strangely enough, there is a high bleeding rate in Germany. Bacterial transmission is also more possible if too few staff are cared for by too many ECMO patients.

And who is expressing displeasure about Corona again? No, exceptionally not the retailers, organizers and restaurants, but the President of the Lower Saxony Higher Administrative Court Dr. Smollich. Because compared to the planned staff cuts at the administrative courts, he sees a re-emerging "flood of lawsuits" when the corona restrictions arise again and increase with increasing incidences. And how that should be dealt with in a timely manner is a mystery to him. The asylum procedures alone have now taken up to 26 months due to insufficient personnel capacities, and over 1 year for general procedures. Well, Dr. Smollich, thanks to the refugee collection measures by ships and special invitations to refugees to Afghanistan, Libya, Turkey and Co., the number will not decrease in the foreseeable future.
