Corona News 10.10.2021 Cost trap: unvaccinated shopping trap

Another day, then the time has come. The state-approved cost trap for unvaccinated people, at least for a large part of the unvaccinated, who for health reasons, reasons of age or reasons that are in the person z. B. of a family doctor, are not exempt, begins on October 11, 2021.

It is about the cost of a corona rapid test, which must be carried out in advance in all locations and places where a 3G rule applies. And the speculations about the cheap costs of such a test are also pass. Because they have nothing to do with what the Ministry of Health paid as reimbursement amount to the test centers for the pure test. In the meantime, many citizens have understood how high the costs can be, 20 euros are not uncommon, higher prices are possible. Mind you, per test. And with that, unvaccinated people are still doing well, according to the will of the Federal and State Ministry of Health, they should be happy that they are still allowed to do something.

Because even if Spahn and Wieler talked at the last press conference this week that no further measures were necessary, it has long since become a self-scooter. Because the way to the voluntary 2G regulation is cleared almost in all federal states. And what has been dismissed by most of the citizens with "It doesn't matter, then I won't go there anymore" will soon fall on their feet. Because in the meantime it is not only the institutions or area events that you don't need to live, but the first grocery stores, discounters, chains are getting serious and want to implement the 2G rule. I would like to see those who have 2 retail stores in a village, one of which says: shopping according to the 2G rule, and the other only with a test. Good times are ahead for the unvaccinated. And then some politicians, pharmacists, organizers and others are amazed that the scam with submitting forged vaccination passports continues to grow, the curve goes up steeply, and we know where there is a need for goods, these are also offered, a bit more expensive as "normal" but the demand is there. It's so simple: Nobody needs to be surprised: first corner people and then when they look for and find ways to get out of there, then everyone is amazed. It is very easy to foresee: Which living being can be cornered and then deal with defenselessly? Oh, completely new knowledge? In connection with the failed continued payment of wages for unvaccinated people when they have to be quarantined, I would like to mention a company chain that has clearly positioned itself with the employees: The EDEKA store in Bautzen. The owner of the store, Mr. Zellmer, sends a letter to the employees in which he assesses the measure as questionable and incorrect and in this case ensures that the workforce will continue to pay their wages. Such an example should make a career for politicians to realize that they cannot simply cheat citizens out of their owed money.

And while the unvaccinated are further vilified and punished with monetary penalties, Altmaier, Federal Minister for Economic Affairs and Energy in the old government, is not too bad to quickly distribute a big gulp from the bottle for the economy and extend it the so-called Bridging Aid III Plus beyond September 30th until the end of 2021. Even self-employed people will continue to be encouraged and rewarded with the so-called Restart Aid Plus. No wonder that he has now resigned quickly to give his place to supposedly young politicians. Has also earned millions, plus his sideline jobs, and I'll bet we'll see him again by the end of 2021, housed in a commercial company as a member of the supervisory board or even on the executive board ?! Typical for outgoing ministers.

Speaking of the Ministry of Health, about the mask deal of the clever Spahn and his men. A lot more went wrong than always stated. So far he has always said to Markus Lanz and Co. that the masks that have been complained about were really not in order. Another lie, that must be a chronic illness with Mr. Spahn. In particular, it seems to be contagious, as several government officials have their problems with truths. More on that later. So Mr. Spahn and his statements. Statements from various sellers of masks and also the first dishes show that the cheese was. At that time, over 100 dealers or mask sellers delivered masks but received no money. And the work of the ministry: We assessed masks and in some

cases complained about things that weren't even stipulated in the contract. Here is an example from a lawyer: Imagine that you sell cars and later complaints are made about them because they cannot swim. The fact is, the first lawsuits at the regional court have already been decided against the Ministry of Health, all of which are paid for by the taxpayer. Really great. A dealer has won 28 million, the largest lawsuit, which among other things is still pending, is over 100 million euros. In total, total values of over 1 billion euros are being negotiated at the relevant regional court.

And what is that ? For weeks, no, for months the morale of the allegedly unvaccinated people was pounded around, and suddenly it came out: The RKI (once again) distributed wrong numbers, there aren't as many unvaccinated people as always claimed. The fact is, and even Mr. Spahn had to give in, the vaccination numbers are around 5% higher than usual, we don't know that exactly now, but it is around 5%. Mr. Spahn thinks that's nice, it makes it easier to get through autumn and winter. (Apart from the fact that you also need suitable winter clothing, heating at home and electricity), which will soon no longer be a problem for Hartz IV recipients, since the rate is supposed to increase by 3 euros per month. With inflation around 3 - 4% monthly also completely adjusted, only when it comes to wasting money and giving away money a la Spahn and other ministers there are no limits. A little digression.

But whether he really gets through the winter with good incidence figures or whatever he lets count, nobody really wants to believe in that. Because: The vaccination breakthroughs are increasing significantly, the recommendation for a third vaccination is already public, and especially with the highly praised Johnson & Johnson vaccine, a particularly high vaccination breakthrough is emerging, so that the around 3.2 million people vaccinated in Germany are urgently recommended to have a second vaccination with an mRNA vaccine. Failed, I can only say about the 3.2 million citizens; fell for the government promises a la Spahn. If you vaccinate Johnson & Johnson, you only need to do it once, you are so safe and so good. I laugh my head off. And then the saying about it: Especially with the India variant, it only shows good effectiveness for a short time. Yes, which variant have we had mainly since January 2021? What a surprise. And Biontech / Pfizer? Now that the news has leaked out that for almost a year only the old vaccine has been muddled through, a new, improved vaccine is suddenly announced out of nowhere, as it was then, for the beginning of 2022. Eat great, there are guaranteed to be 300 million from the federal government and again a Federal Cross of Merit this time in platinum on the double ribbon. And one thing is certain next year: the Nobel Prize in Medicine, because of unwavering further research on the vaccine for reasons of billions in profits. Of course.

But here at least it shows again how stupid statements are to be assessed when the point is to claim that the unvaccinated would block the intensive care beds for other patients. If the vaccine manufacturers were to finally do their homework and bring permanently effective vaccines onto the market, as was always the case in the past, we would also not need intensive care beds for those who have fallen ill after vaccinations, which are increasing more and more, also contrary to the speeches of Mr Spahn with bad Appearance.

Meanwhile, Prof. Streeck and Prof. Lauterbach are not so in agreement on vaccination. Mr. Lauterbach claims, oops, the vaccination status protects worse than the convalescent status, because more antibodies are formed than during vaccination. Now I also know why Mr. Spahn always said that
