First, I would like to briefly address the new "Emergency Brakes Act" in addition to the Infection Protection Act, which the Federal Government wants to initiate. A good thing is that from an incidence of 100, it should apply equally nationwide without exception and different or fewer rules, the same in every district. Below an incidence of 100, it is still a matter for the country to take action. Now comes the eternal political lateral thinker - madness: The federal government needs a 2/3 majority to pass the law by means of an emergency ordinance, but the Greens and the FDP have already refused to approve. So it won't be enough for that. As a result, after lengthy deliberations that are completely irrelevant and irrelevant, the law will be enacted next week by a simple majority. Instead of having quick, uniform rules to block this, as all parties want, they can also agree right away, it doesn't change anything anyway, except that time is wasted again until the law comes anyway - that just doesn't work in some politicians' brains pure? But the members of the Bundestag have thought of themselves: They are exempt from a curfew. Is not that great ?

Then there are the results of the Uschi Glas and Günther Jauch vaccination approval campaign, which is actually just a big fake. Because due to the many inquiries and ridicule of the campaign, the Federal Ministry of Health now sees it as its duty to clarify this. Unfortunately, the education is just as stupid as the campaign, where citizens are mercilessly duped. The ministry's new excuse: The plaster on the arm stands for a vaccination, not for the success of a vaccination. The photo was taken on March 26, 2021. Aha. So if you as a citizen want to show that you are ready to be vaccinated, it is sufficient to put a band-aid on your forehead, everyone will then recognize that you are ready to be vaccinated, and perhaps this will result in a faster vaccination appointment. Yes, dear Federal Ministry of Health, I pull my pants on every day with the pincers. In the meantime, Uschi Glas has also reported to the media such as NTV and expressed her regret - not about the unsuccessful advertising campaign, no, how many bad people there are who you have showered with hateful messages via email and on social media. You have received so much support from people in the medical field. But you can be happy about that.

One (of many) new vaccine - horror news has just been published, which intervenes in the federal government vaccination plan control and throws everything up again, although we have installed the great task force and other special forces, which actually only cost money. Now Johnson & Johnson, which is not yet widespread, is said to be afflicted with side effect problems such as thrombosis, the US authorities are already recommending a vaccination suspension, deliveries to Europe are being postponed. That's such a shame, especially because we received 230,000 cans today. Where do you put it now? Can't we quickly make a recommendation to get rid of it? But no problem, our Ursula v.d.Leyen is already stepping into the breach: Biontech has announced that it will be able to deliver 50 million more doses of vaccine by the end of April - not for Germany, but for the entire EU. That is a lot, because with 27 member countries, given a fair distribution, each country receives around 1.8 million cans: 2 that is enough for a further 900,000 citizens. That is why Mr Söder, who is currently seeing his chances as a candidate for Chancellor, has now signed a Russian contract for the delivery of 2.5 million doses of Sputnik V so that the Bavarians can now be vaccinated quickly and with priority. The delivery should take place after the EU approval - but this is still pending. But Ms. Merkel promises, at least that's what I heard from dubious sources of information, that everyone should receive a vaccination offer by December 24th, 2021. Maybe, because if we go according to the statements of Prof. Wieler RKI and now also from the Chairman of the Health Committee of the Bundestag, Erwin Rüdgel CDU, the vaccination will always be necessary at certain time intervals, a kind of permanent measure that changes due to the constant mutations and The absence of a permanent effect, similar to the flu vaccine, results.

Promises come again from the NTV broadcaster, which shows a report online that the drug called Budesonide Easyhaler 0.4 mg, according to a study from Great Britain, is supposed to help against a serious course of corona because this active ingredient would fight inflammation in the lungs. The moderator of the report says: Strong side effects are not to be expected, at least with budesonide. Oh no ? You can tell right away that moderators have no training in medicine, otherwise this woman wouldn't say such dangerous crap. Decide for yourself whether you, as a reader, consider something or even everything to be a "strong side effect": (Excerpt from the package insert for the medication shown in the report): Frequently fungal infections in the mouth or throat; Occasional cataracts, muscle spasms and tremors; Rarely, suppression of adrenal function; Behavior changes. There are also rare severe allergic reactions. I would like to list only one possible one, whereby I would also like to ask the pharmaceutical company who writes something like that. ATTENTION: If.... If you collapse shortly after the dose inhalation, act as follows: Stop using Easyhaler Budesonide and seek medical advice immediately. Yes, if you still can after a collapse. As a reader, do you notice something? You as a citizen are dumbfounded anew every day. I can't say more about that.

What have we not heard of umpteen new, better watertight hygiene and distance concepts in the last few months so that an industry, an organizer that sports, especially football events, can once again admit visitors or even open them again at all.

But they don't seem that great after all, especially in football there are always big setbacks that shouldn't occur with the DFL's strong concept. Just a few weeks ago, 2 teams from the 2nd Bundesliga, SV Sandhausen and Karlsruher SC, were quarantined because of several corona cases, now it's another team, Holstein Kiel. Also here 2 corona cases in the team. The coach said that some of his players were already in quarantine for the third time. So what use is a hygiene concept if the players don't adhere to it? How else can you explain that they are constantly being quarantined?

And again a mask scandal seems to be opening up, no, this time it is not a question of a politician, but of a clinic director, the Magdeburg University Clinic is the scene of the action. What is striking here is that the mask deliveries that were ordered in autumn 2020 come from the company where the son of the medical director and chairman of the Magdeburg University Hospital is a business partner. Furthermore, there was no invitation to tender for the mask requirement, although there was no more bottleneck during this time, according to a provider who has now filed a lawsuit, among other things because of anti-competitive agreements. The university clinic meanwhile stands behind your boss that he did not influence the selection of the supplier. Let's see what else comes up.

I have already spoken of the Corona mutations in many reports, we have had them for 2 - 3 months since the appearance or the first version became known. And now the quick shot of the EU Commission. They recognized that there too - now. And not only that. You need money to advance research into mutations, and then they are there, the members of the Commission, relentlessly and mercilessly to launch a financing package so that research can be carried out quickly and thoroughly: That is worth a total of 123 million euros, since the MPs leaned far out of the window. I say: A ridiculous sum in rescue packages of 750 billion euros for corona aid for the EU countries. And when you consider that Biontech 2020 alone received aid from the Federal Republic of over 350 million euros ONLY for the research and development of ONE vaccine, a joke. So how many institutions in how many EU countries should research how many mutations? A real EU laughing stock - somehow it sounds familiar - oh yes, it was like that when buying vaccines, what a coincidence.

I will come back to vaccination again, namely by people who have a supervisor and cannot decide for themselves. Did you know how it works then? But you should, because there is a special procedure in the truest sense of the word. A case in Hesse that stands for nationwide processing. The supervisor receives a consent form that was developed by the RKI. Then the data of the person to be vaccinated are entered and ATTENTION: You automatically agree that you will not receive the information sheet about the vaccination, you also do not need to talk to the vaccination doctor in advance. And then get to sign. On request at the RKI, the reference to the state authorities, although the sheet comes from there. The Hessian Ministry of Health refers to the Hessian Ministry of the Interior, there is no answer yet. Incapacitation of citizens or how should I know? And if something happens, for example a death, then nobody is to blame, the sheet has been signed. For me a left number.

I would like to use this example to explain how important the patient is to health insurers in corona times. We all know that the health insurances are burdened with considerable additional costs, especially due to Corona. These are partially recovered by increasing the additional contribution. Of course, billions of additional costs arise from the treatment of millions of new fellow citizens who have never paid a euro into the health insurance, but sometimes receive expensive operations or long-term treatment, especially here one always speaks of trauma. And especially in these Corona times, the subject of hygiene is so important - but not for everyone. Because as the National Association of Statutory Health Insurance Physicians (KBV) reports, a negotiation between it and the central association of statutory health insurance companies has failed; this should be about the assumption of the extremely increased hygiene costs in medical practices due to corona measures. According to surveys by the Central Institute for Statutory Health Insurance (ZI), medical practices had to spend an average of 24,287 euros on hygiene measures alone, even before Corona in 2018. And "alone" is what happens here, you are left alone.

Holding hands with Corona, that is a principle that many who are or were somehow affected by Corona measures, be it through cuts, closings, changes in production, cancellations of events, whatever, have now learned. And the federal government has always delivered, increased, extended in order to be able to sell its measures again and again to the associations, lobbyists, large companies, etc., because as long as the money continues, many do not care whether the business is open or closed. But now it's getting bold: After Ms. Merkel had announced and has now been anchored in the amendment to the new Infection Protection Act, employers are increasingly being taken on board, especially when it comes to testing. The employees should be tested 1-2 times a week in the company or before, however, at the employer. And already the first lobby association reports and emphasizes that the economy is heavily burdened by this measure. And now it comes: the government should take care of a balance. Sure, let's do it, we add another 5 euros per test to all the payments and supports that are already valid. There are companies and associations that never get fed up. And that at the expense of the taxpayer. But they are not interested in whether they can cope with a measly 60% short-time work allowance with a subsequent tax burden.

And in good time before the end of this report, a message reaches me via the Luca app. And it's not that rosy at all. Well, Smudo in particular had always touted this great app in all TV formats where he had the right to speak, how great it was and how safe it was. Great, maybe, there are now doubts when it comes to security. Before the Luca app was launched, Smudo announced that the source code would be published on March 31, 2021. As reported by NTV Online today, the Chaos Computer Club spokesman Neumann criticized this app with the words (quote): Continuous series of security problems (end of quote). In particular, the key fobs, which are intended for people who do not have a cell phone or who do not want to install the app, are their right. Allegedly, after scanning a QR code from someone else's key fob, it should be possible to check in anywhere with the name of the person to whom the key fob belongs, but also to be able to see where it has been checked in so far. The developer has now reacted to this possibility and switched it off - allegedly. But you shouldn't post your QR code anywhere - why actually, if it only works for you?
