

## **Corona News 07/15/2021 The stupid are supposed to be anti-vaccination**

The federal government has hardly noticed that, despite months of dull vaccination propaganda with glass and liquid, many have not allowed themselves to be ripped off and still have not been vaccinated, the much talk by Spahn and Wieler that everyone will get sick at some point if they do not vaccinate and every reasonable citizen would decide in favor of vaccination, it did not work as they had imagined, not only does the federal government deploy heavy artillery, but as with vaccination, more and more people are lined up who oppose vaccination want to put pressure under pressure and want to deny you more and more rights, until more and more people fall over and finally get vaccinated. But even in vaccination centers, if you have already found your way there, you are by no means safe. A well-known spectacular case from Malaysia. In a huge vaccination center in Shah Alam it has now come out that more than 200 of the 450 employees there are infected with the virus. Well, congratulations to all those who would like to be vaccinated who received the first vaccination and who were thus unprotected against the virus. One wonders how that can be; As is customary in Germany, either the employees themselves have already been vaccinated or they do a daily test - probably just a self-test. No wonder that the incidence in Malaysia is over 200. And that with low vaccination coverage.

One would not have to press ahead with the vaccinations at all if the easing in Germany and abroad did not continue to be massively exaggerated, as is currently happening. Regardless of increasing incidence, regardless of the India variant, regardless of anything. Because especially at the European Championships, the incidences all over Europe drove up again, and they will continue to increase. And so that a lockdown no longer has to occur in Germany even with higher values, a new factor is now being introduced, the rest of which we had in earlier times. Whenever an allegedly important factor, such as the R value at that time, becomes too high, you look for a new calculation value in order to play down the contagion and further increase the threshold of the alarm for measures. Now you want to include the occupancy of the intensive care beds. This means that even if we have a million people infected with corona, as long as they do not need intensive medical care, it does not matter. The best example of this is Great Britain. There, all measures should no longer apply in 4 days, they only have an incidence of 360 and an infection rate of just under 8%, that is better. Warners who talk about the fact that the intensive care beds are not occupied until later are ignored. Nobody cares. What a strange change of heart, which I can only explain by the fact that politicians no longer care who gets sick and when, it's about either everyone was sick and recovered or getting vaccinated. Nobody wants healthy people who have never been sick and have no vaccination. And in order for them to understand this, they are subject to more and more restrictions in public life.

The chairman of the World Medical Association, Montgomery, is now also talking about vaccination requirements for certain professional groups in Germany, such as for daycare workers, health professions and teachers, which should be appropriate.

And the first German media are also following suit: Compulsory vaccination must not be a taboo subject. Oh no ? But it was months ago. With specifications from the federal government.

On the other hand, the scandals around Corona shit and fraud are not ending. After we had false vaccination passports in yellow at the beginning, the personal details of the vaccination certificate carriers were not checked during the digital transmission in some pharmacies and so strangers could simply get a digital certification on their mobile phone. And to this day it can neither be blocked nor reversed. And now this: In Brandenburg there are supposed to be over 100,000 citizens !!! have received an incorrect vaccination certificate for 2 vaccinations from the Ministry of Health. Health Minister Nonnemacher, of all people from the Greens, regrets that, she has nothing more to say about it. All of this fits in with the Chaoism in Germany, which has not only prevailed since the vaccinations in relation to Corona. So much mischief, fraud, mismanagement, wrong purchases, you can't even list everything, there has never been in Germany. This shows the quality of the official and political occupations. As soon as it is challenged, everything goes haywire without control.

But what are these vaccinators threatening us with, what meshes they try to use: One of the best examples is the Rhineland-Palatinate Board of Directors Chairman of the Board of Statutory Health Insurance Physicians, Dr. Heinz, who is also a specialist in general medicine in Gensingen. He calls for a series of punitive measures. The basic requirement: The mask must continue to be worn until vaccination has taken place. He does not want to allow visits to stadiums or swimming pools. Even shopping only with a mask. And you can't go on vacation either, because as an unvaccinated person you could bring the virus with you and spread it again. His words: Without a vaccination there is NO freedom. Without this pressure, we will not convince people. Unvaccinated people are a danger to society. A really bright head, at least he thinks himself. I can't remember being able to achieve something through pressure that cannot be achieved otherwise. And the unvaccinated are a danger to society is a cheek. As a doctor, such statements are unacceptable and show his competence in assessing this matter. Because, as a doctor in particular, he has to know what the side effects are and what the side effects of previous vaccines, even the annual flu vaccinations, are like: no comparison. The numbers of mRNA vaccines and AstraZeneca are by far higher and more dramatic, so he should better explain why that is. We remember the "protein research" in a vaccine, where it was found that these substances do not belong in it. The study disappeared quickly, nobody talks about it anymore, clear cover-up, that doesn't fit into the ideal vaccination picture. And now comes out about the USA at Johnson & Johnson, which more than 100 people show up to severe nerve diseases, some of which last longer. This reminds me that on Saturday in Göttingen on the town hall forecourt, free vaccinations were carried out without registration with Johnson & Johnson and that the citizens queued at 7 a.m., although the vaccination was supposed to start at 10 a.m. Unlucky, one can only say that the first side effects will now be announced 2 days later. And because the vaccine wasn't enough, AstraZeneca quickly replenished it, because it still had to be removed, there is no more new one. People no longer shop, why should they?

But also with the two mRNA vaccines Biontech and Moderna, new findings are made public again and again. If they leak. A so-called heart muscle or pericardial inflammation is allowed this time. And then always with these messages the hint how little it would only hit. So far, this has only affected a ridiculous 164 people. If everything is so harmless and insignificant, why do you even talk about it? I hardly believe whether this is so ridiculous for those affected or for the relatives of those whose victims have died. But today there are no longer any small numbers of deaths, real sums have to be found before someone is interested.

According to him, Dr. Heinz probably got a little more criticism than desired. On July 12th, he published a press release on the website of his Association of Statutory Health Insurance Physicians and regretted misleading statements about the vaccination issue. Nah, we already know what he was trying to express. We already know that from the President of the German Medical Association, Dr. Reinhardt, who viewed Markus Lanz's everyday mask wear as not scientifically evaluated and questioned both

self-protection and external protection. Later he too moved away from this statement due to a lot of headwind and reaffirmed the protective function.

I would also like to briefly take up the subject of corona aid again. According to a report, the concert organizer CTS Eventim received around 102 million euros in corona aid for November and December 2020 alone. Of course, the organizers' income has been drastically reduced when the live events are almost completely out of order. But where have the big profits from 2018 and 2019 gone? After all, in 2018 the company achieved the best result since 2015, which was again clearly topped in 2019.

At the end of the day I would like to go into the vaccination speech given by Mrs Merkel a few days ago. She explains very clever things: The R-value rises, the incidence rises, that would be due to the India variant. In addition, there would be a chance that a new variant will emerge. But the vaccination works, severe courses are significantly less, but you need 85% of the 12 - 59 year olds vaccinated, 90% of the over 60 year olds, so that Germany can cope with the variant. If Germany does not manage that, the number of cases will rise again. The central question is how many people get vaccinated. She would therefore like to promote it again. One is mutually vulnerable and dependent on one another. Oh, that's why all the relaxations, so that the citizens who are still healthy can be infected as quickly as possible by vaccinated people who, according to Maaß's will, will soon no longer need to wear mouth and nose protection and thus become wonderful carriers of the viruses, as they do not have any external ones. Have more symptoms and thus no one can tell whether people are infected. She is talking really stupid by claiming that citizens would not be vaccinated because they believed they were physically invulnerable.
